- I. The meeting was called to order about 10:15 a.m. by Erlene Dudley.
- II. Erlene announced the list of proxies and asked for proxies from the floor. Erlene announced the online participants.
- III. Erlene called for an adoption of the agenda. Valerie Darst moved to adopt the agenda as written. Sharon McCaslin seconded. The agenda was adopted.
- IV. Erlene called for approval of the minutes of the February 26, 2010 meeting. Several corrections were mentioned. Angela Gerling motioned to accept the minutes as corrected. Sharon McCaslin seconded. The minutes were approved as corrected.
- V. Information Items
  - a. III Academic Library Directors Symposium (ALDS) Erlene Dudley Erlene, Shirley Baker and Donna Bacon attended this spring's ALDS in California. They had



opportunities to talk to various III staff members, attend presentations from people using different III products, learned what new things III is up to, and found the symposium to be informative overall.

#### VI. Old Business

- a. Revised MOBIUS Bylaws Mollie Dinwiddie, MOBIUS Bylaws Standing Committee The committee looked at several different not-for-profit organizations' bylaws and modeled the MOBIUS bylaws on those while still trying to maintain flexibility for the future and similarity to the current bylaws. Mollie discussed some of the changes and voiced appreciation for all of the comments/questions she received from the members. The only substantial content changes are some of the legal requirements for any not-for-profit. Discussion followed over issues of how the board of directors is determined, board officers, committee structure, what types of libraries could become members, selling services/products to non-MOBIUS entities, how membership meetings can be held, whether members attending a meeting by tele- or video-conference can participate in discussion and/or vote, etc. There was a suggestion to change a section in the bylaws that specifically mentions compensation for board members, but doesn't specify whether board members receive compensation or not. It was agreed to remove the compensation statement from this section. Erlene Dudley thanked Mollie and the committee for their work.
- b. Vote to Allow MOBIUS to File Articles of Incorporation as a Nonprofit Corporation in the State of Missouri Erlene Dudley Sharon McCaslin called to question. There were 44 votes in favor, 0 opposed, and 0 abstentions. The motion carried unanimously.
- c. Vote to Allow MOBIUS to File for Tax-exempt Status with the U.S. Internal Revenue Service Erlene Dudley Erlene called to question. There were 44 votes in favor, 0 opposed, and 0 abstentions. The motion carried unanimously.
- d. The bylaws were revised to coordinate with the previous two documents and accompany MOBIUS's status as a corporation. There were 44 votes in favor, 0 opposed, and 0 abstentions. The motion carried unanimously.

#### VII. New Business

a. Letter to Presidents, etc. regarding changes in MOBIUS - Shirley Baker - After concerns were voiced at the previous Council meeting regarding sharing the changes in MOBIUS with each institution's leadership, Shirley drafted a letter to be sent to the institutions on behalf of MOBIUS. It was suggested that once a final version of the letter is complete, Shirley send the letter to Council members who can then be forwarded to the institution's appropriate person by the Council member. It was agreed this is an acceptable method of notification. Shirley agreed to have another draft letter by the next Executive Committee meeting, April 23.

#### VIII. Interim Executive Director's Report - Donna Bacon

- a. Conference registration is now open. The schedule for the conference and the training day are both online also. The conference day has been extended to 4:30 p.m. to accommodate a few more sessions.
- b. Responses have been received from everyone regarding the EBSCO Academic Search Elite/Business Source Premier database license. Donna is hoping to have a revised spreadsheet with new costs by the end of next week. Work on the contract will start afterwards.



c. MOREnet was able to renegotiate the building lease and there will be an 8% reduction in rent.

- a. Missouri State Library No report.
- b. MOREnet John Gillespie MOREnet was able to retain the governor's recommendation through the House and now the Senate will begin reviewing the budget. MOREnet has been working on a broadband technology opportunities project with another company. The project is for 2700 miles of fiber-optic network for institutions of higher education in the state. An additional number of institutions not connected directly to this backbone will be able to get connected. Currently, MOREnet connects institutions at various connection speeds; this network would provide much better and more consistent speeds.

  - i. Archway Stephanie Tolson announced that St. Charles Community College has officially launched ENCORE.
