MOBIUS Executive Committee Meeting Minutes March 5, 2004

- I. Welcome and Introductions Meeting called to order at 10:05am. Agenda change included adding Executive Session to the end. Motion to approve agenda with change made by Linda Bigelow. Seconded by Laura Rein. Motion approved.
- II. Approval of Minutes The meeting notes from December 3, 2003 were reviewed and resulted in two grammatical changes. Stephanie Tolson moved to accept the minutes with changes noted. Seconded by Linda Bigelow. Motion approved.
- III. Reports:
  - A. MOREnet Tony Wening reported that cutovers were done over a period of several weeks during their maintenance windows with no disruptions reported. HB3 was reported out of the House Education Appropriations Committee and was heard by the Senate Appropriations Committee. A Committee Substitute bill is being drafted in reference to SB1082. MOREnet is completing work on the re-bid for the Newspaper database service. The E-Mints division of MOREnet is being transferred to the office of Stephen Lehmkuhle, Vice president of Academic Affairs.
  - B. Missouri State Library Sara Parker reported on the status of HB1012. There is much concern about the REAL project appropriations. The Missouri State Library hopes to come through at least at current funding level. Two companion bills dealing with electronic versions of items received that revise chapter 181, HB1347 and SB 1044, are both on the consent calendars. HB1384 is a bill on theft or destruction of documents. The online candidacy filing has generated a democratic, republican and libertarian candidate. The newest call for grant proposals is available on their website.
  - C. MLNC unable to attend. Report sent electronically. Deb Ehrstein has been named the new User Services Manager. MLNC's agreement with HW Wilson should be in place by the end of March. MLNC will also be adding McGraw-Hill's AccessMedicine database to their product offerings later this spring. The first 332 titles have been loaded to MLNC netLibrary Collection Two. MLNC members are invited to join netLibrary Collection Two through June 30, 2004. Elections for the MLNC Board of Directors and an additional Members Council Delegate will begin in early March.
- IV. Executive Director Report George Rickerson. MOBIUS appropriation has not yet been addressed in any of the hearings. Records are beginning to be loaded back into the union catalog. The group that visited the storage facility, Edco, in Springfield, was very positive. The Assemblies of God Theological Seminary has contacted MOBIUS for membership. Progress is underway for a new MOBIUS map and the next issue of the MOBIUS newsletter.

- V. MERAC Digital Reference Report Laurie Hathman. The committee reviewed reports on collaborative virtual reference services from four consortia: Washington Research Library Consortium, Utah Academic Library Consortium, Keystone Library Network and OhioLINK. The Executive Committee decided to share the information gathered with the consortium but to not continue with further activities at the present time.
- VI. MAAC Report Loretta Ponzar. The committee reviewed the lending/borrowing statistics and continued to discuss this topic. In an attempt to keep the number of institutions on the list to a minimum, the committee decided to raise the non-returnable ratio to 2.5 or greater. The current working definition of "Lenders of Last Resort" should be available on the MOBIUS website.
- VII. Conference Planning Report Fran Stumpf. Julia Blixrud will be the guest speaker speaking on the topic of "Sustaining and Improving a Growing Consortium." Jerry Kline will possibly speak next year. The concurrent sessions are expanding to 26 with two poster sessions. The schedule will be finalized next week with registration on the web site to open soon. A training session is being organized to follow the day of the conference.
